(4) Pursuant to A.R.S. 12-284©, assess a \$15 surcharge on each postadjudication petition filing in a domestic relations case for the Domestic Relations Education and Mediation Fund.									
(5) Pursuant to A.R.S. 25-504: Subsection M "... a fee shall not be charged to a person who files a request to terminate an order of assignment if an employer is making deduction on multiple assignments for an obligation for the same minor children." Subsection O "... a fee shall not be charged to a party filing a stipulation concerning satisfaction of support obligations."									
(6) Pursuant to A.R.S. 25-205(G), the party who petitioned for transfer must pay the postadjudication fee prescribed in A.R.S 12-284(A), class D to the county to which the proceeding is being transferred.
